

FLETC CHELTENHAM

Regular Walk-On Range

- Law enforcement officers, with agency approval, can report to the open range and qualify without advance notice.
- **Attendees must be active law enforcement officers on full duty status.**
- The Walk-On Range is for **handguns only**.
- Shooters must furnish their own factory ammunition (not from the FLETC Weapons, Ammunition, Storage and Distribution Area (WASDA)), their duty gear (holster and magazine pouches), and duty handgun.
- **The course of fire will be the FLETC Practical Pistol Course (PPC).**
- Shooters are required to attend a FLETC Safety Briefing, held at the beginning of each two-hour session, at 7:30 a.m., 9:30 a.m., 12:00 p.m., or 2:00 p.m.
- Shooters must complete required administrative paperwork.
- Protective equipment (double ears and eye), targets, and cleaning supplies will be provided.

Marksmanship Enhancement Training Program

- A new, four-hour Marksmanship Enhancement Training Program will be offered on alternate Thursday afternoons from 12:00 p.m. – 4:00 p.m.
- Shooters must furnish their own factory ammunition (no more than 200 rounds and not from the FLETC WASDA), their duty gear (holster and magazine pouches), and duty **handgun**.
- The program will focus on marksmanship and enhanced weapons handling skills.
- Students must pre-register through the Cheltenham Scheduling Office (contact information below).
